

Meeting Schedule

Fair Board meets in January, March, May, July, September, November. Either the 2nd or 3rd Monday.

7:00 pm General board and 8:00 pm Rigby Board.

Livestock Committee meets annually in October. Proposed rule changes will be added to agenda after a written request is submitted. Rule change requests must be submitted prior to September 30.

Market Sale Committees meet as needed.

General Rules 4-H

Advisors: Sue Walker, 4-H Program Assistant; Amanda Hickman, 4-H Program Assistant; Deanna Poulson, Extension Educator; Joseph Sagers, Extension Educator; Ruth Hale, Office Manager

There will be three showmanship divisions according to age, as of January 1st:

Junior: Ages 8-10 Intermediate: Ages 11-13 Senior: Ages 14-18

PREMIUMS: Premiums will be paid as follows: Blue: \$3.00 Red: \$2.00 White: \$1.00

- 1. All 4-H work will be judged according to 4-H standards and awarded on a merit based system.
- 2. 4-H exhibitors will comply with all general rules of the Jefferson County Fair and market sale.
- 3. 4-H animals will be shown by 4-H members only, except by special permission of Extension Personnel.
- 4. Any 4-H member may exhibit an animal at either the Rigby Fair or the Mud Lake Fair, but not at both fairs.
- 5. Completed record books, are required.
 - 5a. Completed record books is a 3 ring binder and will include the following completed pages: signatures, goals, demonstrations, activity log, expense log, animal health and production record, income, story and involvement report.
 - 5b. Exhibitors receiving a white ribbon on their books will not be allowed to compete in any show, including the market sale. A one week grace period will be granted for the exhibitors to correct problems within their record books to bring it up to a red or blue standard. White ribbon books are not eligible for any rosette awards.
- 6. Each large animal will be individually identified, with either a ear tag or tattoo.
- 7. Each exhibitor will be register through 4h.zsuite.org and pay their registration fee by their respective weighin date to avoid a late fee. See each specie for exact deadline dates.
- 8. Market animals are required to have a bill of sale.
- 9. All market animal species (Beef, Sheep, Swine, Goat) exhibitors are required to complete a minimum of 5 Livestock Lessons.
- 10. Dairy cow or dairy goat, rabbit (pet and market) and poultry will complete skills checklist for respective specie.
- 11. 4-H members exhibiting beef, dairy, sheep, swine, goat, poultry or rabbit projects must enter the showman-ship contest.
- 12. 4-H exhibitors will provide the primary care and training for animals.
- 13. Each 4-H member is limited to two entries in each class of livestock for county fair.
- 14. Dual Enrollment in 4-H and FFA.
 - 14a. Youth may be members of 4-H and FFA at the same time as long as the member meets requirements for both programs, including maintaining records for each organization.
 - 14b. During initial weigh-ins it must be clearly stated if they will exhibit in 4-H or FFA. Members may not show the same project for both FFA and 4-H.
 - 14c. Jefferson County is open to all youth that choose to participate exclusively in a Jefferson County 4H or FFA program. (Exhibitors that have been banned from another fair may petition the fair board to participate in the Jefferson County Fair)
 - 14d. Projects will be defined per State 4-H project list. Projects are as follows: Market Beef, Breeding Beef, Dairy Cattle, Dairy Goat, Pet Goat, Breeding Meat Goat, Market Goat, Poultry, Pet Rabbit, Market Rabbit, Market Sheep, Breeding Sheep, Breeding Swine, Market Swine.

- 15. All 4H breeding stock will be declared by May 17. To declare breeding animals that may be shown at the fair send the herd tag, scrapies or bangs tag along with animal breed to the 4H office via email or hard copy paper. Undeclared animals may be shown in Open Class but not in 4H breeding.
- 16. All market animals must be registered on Jeffco.showandfair.com prior to weigh-in day. Animals not on the website will not be allowed to cross the scale.

General Rules FFA

Advisors: Robert Hale, Lex Godfrey, Casey Sanders, Austin Davis, Mindy Raymond, Billie Jo Blackson, Jake Landon

Entries in both agriculture and livestock shall be limited to active FFA Members in good standing in their local chapter and who are regularly enrolled as students of Agricultural Education. Eligible members are:

- Continuing FFA Members
- Students who graduated last May
- Incoming 9th grade students of Agricultural Education
- 8th grade FFA members are eligible as long as they have completed an Exploring Agricultural Education course as a 7th grade FFA member.
- 1. Each FFA Member is limited to one exhibit in each class of crops and the entries must have been produced on the farm operated by student or his parents.
- 2. County FFA Members may show at only one fair, either Mud Lake or Rigby for credit or awards.
- 3. Each FFA Member is limited to two entries in each class of livestock.
- 4. The FFA Member must own the livestock exhibits or the member must have 50% or more financial interest.
- 5. Market sale animals will be governed by Market Sale rules.
- 6. Health requirements shall be the same as for open entries.
- 7. All entries to be graded according to breed standards and premiums to be paid based on the rating of A, B and C for both crops and livestock.
- 8. All exhibits shall comply with open class regulations.
- 9. All animals exhibited must be in record books.
- 10. Completed record books, are required.

10a. Exhibitors receiving a white ribbon on their books will not be allowed to compete in any show, including the market sale. A one week grace period will be granted for the exhibitors to correct problems within their record books to bring it up to a red or blue standard. White ribbon books are not eligible for any rosette awards.

10b. Record books must include (accurate records kept in Market or Breeding Manager).

Prior to fair.

- 1. Complete SAE Plan
- 2. Accurate and complete financial entries (Cash and/or Non Cash)
 Purchase or Transfer of animal, feed, vet costs, supplies, ect.
- 3. Journal entries every other week.

Should show time in feeding, care, training, show preparation

After fair—prior to receiving premium check and sale check.

- 4. Final journal and financial entries for the show and sale.
- 5. Completed Annual Review (clipboard)
- 11. All FFA exhibits must follow all general rules and barn and arena rules.
- 12. All FFA members exhibiting beef, dairy, sheep, swine, goat, poultry, or rabbit projects must enter show-manship.
- 13. Each large animal will be individually identified, with either an ear tag or tattoo.
- 14. Dual Enrollment in 4-H and FFA.
 - 14a. Youth may be members of 4-H and FFA at the same time as long as the member meets requirements for both programs, including maintaining records for each organization.

- 14b. During initial weigh-ins it must be clearly stated if they will exhibit in 4-H or FFA. Members may not show the same project for both FFA and 4-H.
- 15. Jefferson County is open to all youth that choose to participate exclusively in a Jefferson County 4H or FFA program. (Exhibitors that have been banned from another fair may petition the fair board to participate in the Jefferson County Fair)
- 16. All market animals must be registered on Jeffco.showandfair.com prior to weigh-in day. Animals not on the website will not be allowed to cross the scale.

General Rules Fair & Barn

Every effort has been made to insure the accuracy of this exhibitor handbook. However, exhibitors are cautioned that the current rules and regulations of the Jefferson County Fair, as interpreted by the Fair Board, take precedence over this listing due to the possibility of typographical error or inadvertent omission.

In the event of conflict between the general rules and the special rules governing the various species, the special rules will take precedence.

The Board reserves the final and absolute right to interpret these rules and regulations and arbitrarily settle and determine all matters, questions and differences in regard thereto, or otherwise arising out of, connected with or incident to the Fair. The Board reserves the right to amend or add to these rules, as it, in its judgment, may deem advisable.

- 1. All entries are accepted with the understanding that the Fair Officials shall not be held responsible for any damage or loss that may arise to livestock on exhibition or sale.
- 2. The only ribbons that may be displayed are those won at the current year's Jefferson County Fair.
- 3. Exhibitors must comply with all health regulations for each department.
- 4. Each exhibitor of livestock and small animals are expected to keep their pens and stalls clean and sanitary. Stalls and pens must be cleaned by 9:00 a.m. each day. Failure to do so will result in a \$50.00 fine. Also all animals must be fed daily, including Saturday morning. All stalls and pens must be cleaned after animals are removed. Fine will be collected by withholding premiums or withheld from market sale check.
- 5. No exhibits will be released prior to the time listed on the calendar (page 2) without superintendent authorization. NO EXCEPTIONS.
- 6. The Board of Directors and management reserve the right to accept entries after closing dates, if good and sufficient reasons for the delay are given, and reserve the right to offer classifications and premiums for any recognized breed of livestock, or other exhibit, at their discretion.
- 7. The management reserves the right to reject any exhibits, if it is objectionable in any way, if it requires an excessive amount of space, or if the capacity of the department has been reached.
- 8. All animals on the grounds must be shown in a class.
- 9. All animals on the grounds will be clean, fit and healthy or they will be removed from the fairgrounds.
- 10. Any exhibitor treating animals inhumanly will be disqualified and asked to leave the grounds.
- 11. Disrespect shown to any award or to any judge by an exhibitor forfeits all the awards made to him/her.
- 12. All 4-H and FFA youth may also enter animals in open class.
- 13. Market animals cannot be shown in open class. Animals shown in the market class may not be shown in any breeding class, and animals shown in the breeding animal class may not be shown in the market class.
- 14. The animal entered in Round Robin competition will be the exhibitor's winning animal that was used to qualify.
- 15. There will be no injections given on the grounds unless the barn chairman and veterinarian have been notified. Injections will only be given under the direction of a veterinarian
- 16. Any liquid or substance not considered part of an accepted and normal diet for livestock is deemed illegal and inhumane. For example: the use of alcoholic or carbonated beverages as a drench or filler.
- 17. Drenching is not allowed unless a member of the Livestock Committee is present and it is needed for emergency purposes only.
- 18. Livestock committee reserves the right to disqualify an animal that can not be controlled by the exhibitor.
- 19. Each exhibitor may only have 2 entries per class, in both the youth (4-H and FFA) and open class classes.
- 20. Specie chairman will assign pens by club. Exhibitors having space assigned to them will not be permitted to change locations without first having obtained permission from the superintendent of the department under penalty of forfeiture of premiums.

- 21. If youth have a **scheduling conflict** with a show or the market sale, youth will need to contact the livestock committee between 4:00-5:00 p.m. at the Fair office on Tuesday, to make individual arrangements. If the youth does not do this their animal will not sale.
- 22. All animals shown in group classes must be owned by the individual.
- 23. Exhibitors must in all cases be the bona fide owners of animals exhibited by them, except where otherwise specified.
- 24. No straw will be used for bedding.
- 25. Exhibitors will bring their own feed and care for their own animals.
- 26. Awards will be made according to the merits of the exhibit. The judge may disqualify or award 2nd, 3rd premiums at this discretion. Special awards will be made only after the judges have agreed with the manager that such awards should be made.
- 27. Any person attempting to influence the judges in their decisions in any manner will forfeit all awards and will be excluded from all competition and exhibition.
- 28. No persons will be permitted in the ring during judging except the show committee.
- 29. Exhibitors trailers are to be parked off site or on the race track.
- 30. Each open class livestock exhibitor will pay a \$1 entry fee per class for dairy, beef, sheep, goat, swine, rabbit, and poultry.
- 31. Open class animals will be judged 1st, 2nd, 3rd, and 4th in each class.
- 32. Animals designated for EISF Jr Market Livestock Events must be tagged and tissue sampled at county beginning weigh-in. Animals will be tagged with EISF tags.
 - A. If a tag is lost contact your county office immediately. Tissue samples will be taken, if they match then the animal will be retagged. If samples do not match, the participant will be disqualified and permanently banned from all future 4-H/FFA EISF Jr. Livestock Events.
 - B. Youth will pay \$10.00 for tag and tissue sampling kit.
- 33. All animals destined for the Eastern Idaho State Fair (EISF) will be included in record books, either 4-H portfolios or SAE books.
- 34. Peewee showman entries are preferred early, along with the open class entries, however they will be accepted the day of the show.
- 35. All shows will begin with FFA showmanship followed by 4-H Senior, Intermediate, Junior, Novice. Following showmanship, quality classes will be begin.
- 36. To file a grievance:
 - A. Submit grievance form, along with \$20 fee to specie chair.
 - B. Specie chair will submit grievance to grievance committee.
- 37. The judges will set the class sizes, for showmanship and quality. Judge also determines number of exhibitors to come back for the final drive.
- 38. Rigby Fair Board will retain a veterinary service for wellness checks and any animal emergency that may arise during the fair week. The purpose of wellness checks is to prevent entry of any animal with infectious disease and the exhibition of any animal that does not meet the health criteria of the 4-H, FFA, and Jefferson County Fair requirements. The contracted vet will be on site during the final weigh-ins. The Barn Manager and Species Chair will be consulted if there are any animals that do not meet the health requirements. Any animals that fail health requirements will be immediately released and sent home with the exhibitor.
- 39. Jefferson County is open to all youth that choose to participate exclusively in a Jefferson County 4H or FFA program. (Exhibitors that have been banned from another fair may petition the fair board to participate in the Jefferson County Fair)
- 40. ALL animals/exhibits will be declared by pre-entry. Entry forms will be available via <u>z-suites</u>, <u>AET</u>, the <u>county website or at the 4-H office</u>. Entry forms will be completed per specie per exhibitor. All shows (4H, FFA, Open Class) and classes will be declared, those include showmanship, breeding, market, and pet.
- 41. All open and breeding animals will be declared and registered to participate in the fair by the last Friday in July. No late additions will be accepted.

- 42. Process for proposed rule changes:
 - A. Standing rules and policies that govern the Livestock Committee and qualifications and guidelines for youth and animals are stated in the Rigby, Jefferson County Livestock Rulebook.
 - i. Proposed rule changes from general public will be addressed at the October meeting.
 - ii. Proposed changes will be submitted in a written form and delivered to the secretary of the Live-stock Committee prior to October 1.
- 43. Chain of command: in the event of the complaint or problem, solve issues on the lowest level possible.
 - A. 4H leader or FFA advisor
 - B. Specie chair
 - C. Barn chairman
 - D. Livestock committee
 - E. Rigby, Jefferson Fair Board

Awards

- 1. Awards are based on the merit of the project
- 2. Open class will be awarded:
 - A. Classes will be awarded flats 1, 2, 3, 4
 - B. Rosettes will be awarded for the Champion classes listed
 - C. Trophies or Plagues will be given to the highest placing over all animal
- 3. 4-H and FFA classes will be awarded:
 - A. Classes will be awarded Blue, Red, or White flats
 - B. Star Class ribbons will be given to the top exhibitor(s) in each class which are called back by the judge for the Champion Drive.
 - C. Rosettes will be awarded in the Champion Drive or Star Class.
- 4. Buckles and special awards must be sponsored prior to February 15.
- 5. Special awards must be approved through the appropriate committee or board and must be even across the specie in consideration.

Check in & Check out Protocol

Check-in Protocol:

- A. Check the schedule on page 2 for exact times for each species
- B. Market animals will check in at the scale
- C. No animals may be placed in pens/cages without permission of specie chair or designee.
- D. Non-market (breeding and pet) large animals will check-in at their stalls at the designated time
- D. Rabbits and poultry will check-in at the small animal barn
- E. See rule 20 page 8 for pen/cage assignments.

Check-out Protocol - Beef, Sheep, Swine, Goats

- A. All decorations and livestock/animal supplies will be taken down between 11-12 on Saturday.
- B. At noon on Saturday, non-market (breeding and pet) animal (sheep, goats, beef, swine) exhibitors will be at their pens at noon to be checked out with specie chair.
- C. Sheep, goat, and pig barns will be locked and only authorized personal will be allowed in the barns to help with loading market animals.
- D. At noon the parking will be cleared to make room for removal of market animals.
- E. The beef barn will be cleaned out starting at noon. (Beef trailers must stay clear of the goat, sheep, swine barns to allow loading)
- F. At 3:00 pm barns will be opened back up for clean up and tear down. All exhibitors are expected to help.
- G. No premiums will be distributed until 4:00 pm. Minor adjustment will be posted.

Check-out Protocol - Rabbits, Poultry

- A. All decorations and animals will remain in cages until 11:00 am on Saturday.
- B. Beginning at noon on Saturday, market rabbits may be removed from pens by the buyer(s).
- C. Poultry exhibitors shall remove cages, clean them thoroughly with water, and replace them in the barn. Shavings, droppings, and drop cloths are to be removed and placed in trash.
- D. Rabbit exhibitors shall work cooperatively to remove plastic, shavings, and droppings and wash the trays, if needed.
- E. The barn shall be swept thoroughly.
- F. No premiums will be distributed until 4 p.m. Minor adjustment will be posted.

Market Sale Rules and Regulations

- 1. All market stock entering the auction ring must be sold. No animals sold through any other sale within 60 days prior to the Fair shall be permitted in this market show or sale.
- 2. All animals entered in the Market Stock Sale must have been shown in the show ring and have received a blue or red ribbon.
- 3. It is required that each 4-H and FFA member be the bona fide owner of each animal that he or she has exhibited. The County Agent or FFA Advisor will be responsible for this verification.
- 4. Jefferson County is open to all youth that choose to participate exclusively in a Jefferson County 4H or FFA program. (Exhibitors that have been banned from another fair may petition the fair board to participate in the Jefferson County Fair)
- 5. Beginning weigh-in will be required for all market animals. Livestock will be tagged with county tags and market rabbits will be tattooed at the beginning weigh-in.
- 6. Exhibitors will be allowed to sell only one animal at the market sale, with the following exception:
 - A. That all Grand Champion and Reserve Champion animals must sell. (Even in the event that an exhibitor has a Champion or a Reserve Champion in one or more species.)
- 8. At the discretion of the Livestock Committee any hog will be disqualified if it shows evidence of pigginess, scars, sores, bruises or blemishes that may impair the carcass.
- 9. Terms of sale will be CASH.
- 10. A brand inspection must accompany any market steer or market heifer sold.
- 11. Sheep and goats will have a 3% shrink applied from the weigh in weight to determine the sale weight.
- 12. Beef will have a 4% shrink applied from the weigh in weight to determine the sale weight.
- 13. A commission charge of 2% will be deducted from each animal, including sale price and additional boosts.
- 14. All market animals will be the responsibility of the youth until Saturday at 12:00 noon including animals that have been sold.
- 15. All extra animals, (i.e. animals not going through the sale ring but were weighed in at the beginning weigh in) must have destination declared to specie chairman or market sale secretary by 1 hour after their last show. Forms available in the rule book or fair office.
 - A. Extra animals that have not been declared by set times will be the exhibitors responsibility and will not go on any trailers designated by the Market Sale Committee.
- 17. The Market Sale committee makes all final decisions and the money is distributed through the fair board secretary.
- 18. Any animal that participates in a Jefferson County Fair market class is NOT allowed to show in any other quality class, EISF, or county fair.
- 19. Each market sale youth is required to show proof of Thank You given to their respective buyer. Checks will not be distributed until youth have completed this task.
 - A. Youth have been asked NOT to handout buyer thank yous and/or gifts the night of the sale. Please reserve this for another time.
 - B. Proof of Thank You can be a simple picture and will be sent to the Jefferson County 4H office or to FFA Advisors.
- 20. The sale program will sell animals as determined by the market show placing.
 - A. Grand and Reserve will be sold at the beginning of the sale.
 - B. All blue ribbon animals will be sold prior to red ribbon animals.
 - C. Species will be rotated within the sale order.
- 21. Buyer information will be available on Jeffco.showandfair.com immediately following the sale. Exhibitors are asked not to request this information on Friday night of the sale or Saturday of the Fair.
- 22. Contested weights on market animals will need to be called immediately upon leaving the scale. Animal will be returned to the scale and reweighed. No other re-weighs will be allowed.
- 23. For any animal sold through the sale, the floor buyer has until shipping to refuse loading and purchase of the animal. If a floor buyer does not take receipt of an animal, the seller will forfeit the floor value of the animal and retain ownership. The owner will still receive the sale amount above the floor value.
- 24. If a tag is lost, notify the 4H office immediately. Failing to do so will disqualify the animal from the sale. The following pictures will be requested:
 - a. the ripped ear,

- b. the found tag, if possible,
- c. pictures of the animal, including ear notches, scrapies tags, tattoos, or other distinguishing features.
- 25. Any market sale tagged animal not being shown in a market class will have the county tag removed at final weigh-in.
- 26. Exhibitor checks will be distributed after all monies are collected or within 60 days of the market sale.
- 27. No intact males (crytorchids or stags) will be allowed in large animal market classes. Exhibit can be removed or disqualified up to the end of the market class. The final decision to be made by the specie judge or vet.

Youth and families are asked to NOT sit in the bleachers the night of the sale. Leave these seats for the buyers.

Jefferson County Market Animal Sale: Declaration Form
